mechanics for judicial approval of settlement for ~~the~~ death involving minor children beneficiaries.

1. Attorney petitions the Richmond Circuit Court to have Mrs. Johnson named guardian of the minor children.
2. Mrs. Johnson's attorney is named trustee for the adult children, Mrs. Johnson, and the minor children.
3. After Mrs. Johnson is named guardian, the attorney pays out all the money in the trust to her. She then holds the minor children's share.
4. The beauty of this is that it avoids ~~the~~ bank fees for trustees and escrow accounts - etc.
5. The children - minor - are also represented by a guardian ad litem.
6. Needed orders:
 - ① order appointing guardian ad litem.
 - ② order for disbursement of the funds.
 - ③ order dismissing case w/ prejudice.
