Dr. Janice Underwood presented on behalf of the Taskforce. The taskforce is made up of the following experts in three agencies (Governor's Office, VDH and VDEM).

The Taskforce is working to assess needs and gaps, both vertically and horizontally, felt by minority communities regarding access to healthcare. The broader Health Equity Task Force, which the Leadership Taskforce represents, is at the top of the Coronavirus Unified Command. This includes state agencies and advocacy groups. The Taskforce is focused on the following three buckets: Equity Education. Community Engagement, and Internal Collaborations.

Key presentation takeaways:

- Virginia is the only state that proactively created a Health Equity Task Force. It was formed March 13, 2020. Task Force is operational and uses a whole government approach.
- Sable Nelson: discussed what has been done so far with a focus on using data and paying close attention to vulnerable communities. Based on that data the Taskforce is tailoring approaches taken to each individual community. More info can be found on VDH's website how to apply a health equity lens (for agencies and contract tracers). Black, Asian, Latinx, Rural, Disability. Collect data. Submit questions ahead of time and summarize info into an FAQ.
- Working with all the state agencies, Health Equity Task Force sat down with every state agency to help craft their proposal, then created a document to support those proposals for the CARES Act funding.

The Taskforce will be hosting a townhall at 7pm [on May 21st] on ABC8 to hear Virginians' concerns.
